## 3. Review of Events

## Summer Performance

Very positive feedback from parents/carers about the event and Ms. Withers passed on a big thank you to the committee for creating a great community/festival feeling. We made a profit of $£ 554.79$. This includes $£ 26$ made on the Uniform Exchange.

Key learnings for next time:

- more veggie options (not just hot dogs)
- need an alternative to Mr.Crossman calling the raffle. Charlotte was suggested (and accepted)
- Jolly Jam Jars was a big success and we should do again


## September Picnic

Estimate that around 150 people attended from Y 7 and Y 8 and there was lots of connecting across year groups.
Some very enthusiastic Y 7 parents on the PTA at their local primaries who may be interested in joining FOCSED.

## Southwark to Sea Walk

Lots of really positive feedback. About 50 set off (some had to drop out en route) mainly from Y8. We agreed that the time of year was perfect to do the walk and that the resource prepared by Mr.Fogerty was fantastic and should be emailed out beforehand in future.

We discussed the possibility of having a separate walk for Y 7 next year (i.e. each year group walks separately). We need a Y7 parent to take this on

## 5. Ongoing Initiatives Update

## Books \& Donation Scheme

Charlotte delivered 100 good quality second hand books to the school library - of which only two were rejected!
Charlotte and Louise have been liaising with Emily Seed (School Librarian) and Alastair (Rye Books) over the Book Donation scheme. Emily is drawing up a wish list of books and Charlotte has drafted a letter for parents and friends. As soon as the list is agreed we'll be good to go ahead. Letter needs to go in the newsletter and a hard copy in book bags. Charlotte to send letter to Audrey and Lizzie to publicise.

## Uniform Exchange
